**GENERAL MEMBERSHIP PRIVILEGES AND RULES**

1. If you are unable to attend your curling match – notify your skip. If your team is unable to play, the skip is to notify opponent as soon as possible.
2. Bar revenue helps keep membership fees low so your payment of beverages, including bottled water and juice when consumed is expected. Soda and popcorn are available to members only without charge. No popcorn allowed out of upper level.
3. If non-members are present at bar, they must pay the non-members rates, as posted.
4. Alcoholic beverages are not to be consumed on the main lobby floor. All liquor bottles belonging to members should be secured in lockers when not present.
5. **STREET SHOES ARE THE PRIMARY SOURCE OF DEBRIS COMING INTO THE CURLING CLUB AND ARE NOT ALLOWED ON CURLING ICE. IF NON-CURLING SHOES ARE USED, THEY MUST BE CLEAN, DRY AND NOT WORN OUT OF DOORS.**
6. Keep hands/knees off ice surface after delivery to prevent debris and melting in front of the house.
7. Members are encouraged to clean up after themselves and if last to leave, make sure lights are off and doors locked.
8. Report any suspicious activity or equipment malfunctions to Pete Fenson or any Board member.
9. Curling lessons and/or equipment are available though Pete Fenson.
