## **Bemidji Curling Club/USA Curling - COMBINED PARTICIPANT RELEASE (ADULTS & MINORS)**

The undersigned participant or parent/legal guardian of the minor participant ("Participant") hereby represents and agrees as follows:

1. Acknowledgment of Risk: I understand that curling is played on ice and requires physical fitness. I (or the Minor) possess such fitness and acknowledge the risk of serious injury or death.

2. Release of Liability: In consideration of being allowed access to the Ice House (defined below) for curling activities, I, for myself or the Minor, and our respective estates, heirs, successors, and representatives, hereby release and discharge:

- Any club, team, or organization affiliated with the United States Curling Association, Inc. ("USCA"),
- USCA and its successors,
- Any regional curling association affiliated with USCA,
- The employees, officers, and directors of the above entities (collectively, the "Releasees"),

from any and all claims, liabilities, or damages related to physical, mental, or bodily injury occurring in the Ice House or adjacent areas, except in cases of willful, intentional, reckless, or grossly negligent conduct by a Releasee.

3. Definition of Ice House: The Ice House refers to any room within a building containing sheets of ice used for curling, owned and/or operated by a Club.

4. Medical Authorization (Minors Only): If the Minor requires urgent medical attention and I cannot be reached, I authorize emergency personnel and medical practitioners selected by Releasees or chaperones to take necessary measures and disclose relevant medical information.

5. Legal Capacity & Revocation: I certify that I am either:

- At least 18 years old and legally able to sign this release, or
- The parent/legal guardian of the Minor and legally empowered to bind the Minor to this release.

I revoke any prior releases or waivers previously executed in favor of any Releasees.

6. Severability: If any provision of this release is found unenforceable, the remainder shall remain in full force. Courts may modify unenforceable provisions to the maximum extent permitted by law.
